BOARD MEETING MINUTES

(UNAPPROVED)

Call to order- 6:30 p.m.

Pledge of Allegiance

- I. Recognition of a Quorum
 - a. Knee, Millinger, Schoettmer, Haley, DeCesari, Miller, Pedigo, and Hegenbarth present
 - b. Clark absent
- II. Approval of Minutes – March 20th, 2024
 - a. Motion by DeCesari to approve March 20th, 2024, minutes. Second Pedigo. Motion carried.
- III. Recognition of Members and Guests
 - a. Mr. Goley addressed his recent ECC application regarding setback from road for new house build. Board reaffirmed that Mr. Goley's previous ECC application (November 2023) was sufficient for county approval of house build and setback.
 - b. Mr. Olsen addressed the brightness of the light at the lower boat ramp. The Board assured Mr. Olsen that this is in process with Ameren to rectify the light brightness.
- IV. Finance Report – Schoettmer
 - a. As of March 31st, 2024, there was \$643,174.63 in the Operating account and \$200,033.42 in the Reserve account.
 - b. Motion by Schoettmer to move the previously agreed upon funds from the Operating account to Reserve account. Second Millinger. Motion carried.
 - c. Finance Committee meetings will resume to monthly occurrences – will work with GM to set up times.
 - d. Motion by Pedigo to accept the Finance Report. Second DeCesari. Motion carried
- V. General Manager Report – Rice
 - a. As of today, there are 72 members who have not paid their 2024 Association Dues.
 - b. The Pool-Pass program will be purchased and set up next week.
- VI. Club Reports
 - a. Activities Club –Clark
 - i. No report
 - b. Sportsman's Club –DeCesari
 - i. Old Upper Boat Ramp Dock torn down last Wednesday
 - ii. The Trivia night was successful
 - iii. The Club donated \$100 to Illini Bluffs After Prom and St. Jude
 - iv. Fish Fry is scheduled for May 11th, GM to arrange for liquor and food licenses
 - v. Dog Park Club requested the Club donate food for an event in August with little detail. Club voted no and requested someone come to the SC meeting and make a formal request with details.
 - c. Dog Park Club-Haffner Sent Report by Email
 - i. Preparing for LC Garage Sale Fundraiser on May 18th with ad going in paper by end of the month.
 - ii. Working on 4th of July basket preparations getting donations, etc.
 - iii. Tentative Texas Hold 'Em Tournament August 17th.
 - iv. Next meeting scheduled for May 8th at 6:30 p.m.
