Call to order- 6:30 p.m.

Pledge of Allegiance

  - a. All members present: Miller, DeCesari, Schoettmer, Millinger, Hegenbarth, Jones, Howard, Robertson and Lano.
- II. Approval of Minutes February 19<sup>th</sup>, 2025
  - a. Motion by Millinger to approve February 19, 2025, minutes. Second DeCesari. Motion carried.
- III. Recognition of Members and Guests
  - a. Dooley Lot 24 addressed their issue with one owner of lot having amenity rights each year. Would like the option to pay an additional set of dues for second owners for yearly amenity rights. Millinger addressed this and said it will be discussed later in the meeting.
- IV. Shannon Meyers Limestone Township Highway Commissioner Candidate
  - a. Meyers spoke about why he would like to be elected for Limestone Township Highway Commissioner and some of the issues he would address.
- V. Finance Report Schoettmer
  - a. At the end of February, our operating account had \$410,972.95.

The Collections process will also begin on April 1<sup>st</sup> with May 1<sup>st</sup> being the tentative date that the overdue amounts will be sent to our Collections Agency.


